Meet & Greet at the Hub

This year we are starting a new activity. On July 2, the Sunday before the 4th, we are getting together at the Hub to celebrate the new summer season at Cranberry Lake.

CLEAN..DRAIN..DRY REGULATIONS in the Adirondack Park, by Carol Murray.

Watercraft can transport aquatic invasive species. Cleaning, Draining, and Drying boats protects waters by reducing the possibility of these being introduced into waterways.

Beginning in 2022, a new state law required all motorboats launching into public water-bodies within 10 miles of the Adirondack Park comply with new regulations AND operators must be in possession of a self-issued or steward-issued certificate. Motorboat operators should perform all necessary Clean.Drain.Dry steps or visit a steward-run Watercraft Inspection Station and then complete these certificates before launching. These certificates MUST be kept with the motorboat when launched and produced if asked. All vessels that are driven with a motor (electric or fuel driven) REGARDLESS OF SIZE, are considered motorized watercraft, including trolling motors. Self-powered vessels, canoes or kayaks, are exempt from carrying a certificate, but operators are still required to Clean.Drain.Dry the vessel and equipment. Watercraft re-launched into the same water-body do not need a new certificate. Operators should keep the certification form obtained during the initial launch. Our annual Canoe/Kayak Race will take place August 12. Although operators of canoes and kayaks are not required to carry the Clean.Drain.Dry certificate, they are required to make sure their vessel is not harboring any invasive species by following the cleansing steps.

Additionally, some kayaks, more specifically racing kayaks, have a foot-operated bailing system which is recommended to be inspected before launching. We will have certificates available during the

pre-race inspection.



Navigation Wall Maps

Brianna's Law

Safe navigation on Cranberry Lake is one of our missions. Have you heard about Brianna's Law? This law requires operators of personal watercraft, including jet skis, fishing boats, pontoon boats, racing boats and everything in between to be of age 14 or greater and complete a boating safety course. Named after 11-year-old Brianna Lieneck, who died in a 2005 boating accident, the law intends to ensure that everyone operating a boat in New York State is competent enough to do so. By January 1, 2025, every operator of a motorized boat in New York State must have obtained a boating safety certificate in order to legally operate their boats. As of today, everyone 40 years old and younger must have a certificate.

Not complying with the boating safety education requirements in New York State can result in a fine up to \$250. If the boat is powered by any type of motor, it likely requires a certified operator. If you're operating a sailboat, kayak, paddleboard, canoe, rowboat or any other unmotorized vessel, you're not required to obtain a boating safety certificate; however, it is recommended. While there are no boating licenses for personal boats in New York, there are boating safety education certificate requirements. The New York State Office of Parks, Recreation and Historic Preservation is managing the NYS Boater Safety Program. Here is a link to their Website for more information:
